The Headquarters Hotel will be the **Courtyard by Marriott**, 589 Carl Vinson Parkway, Warner Robins, Ga 31088, tel # 478-602-6200. The Headquarters Hotel has granted a reduced rate for those attending at \$124.00 + tax. This rate has been secured for August 22<sup>nd</sup>, 23<sup>rd</sup>, 24<sup>th</sup> and the 25<sup>th</sup>, 2017. When making your Reservations, identify yourself as a party of "**Southeastern Shrine Association's 83<sup>rd</sup> Annual Conference**". **Cut-Off-Date** for Headquarters Hotel Reservations is **August 04, 2017**.

A listing of the local Hotels (attachment (A)) are within several minutes of the Headquarters Hotel and the Galleria Mall, which will be the location for all competitions.
